This has reference to the Council's NIT No. 01/2026/CCRYN dated 17.01.2026 uploaded on CPP Portal and Council's website regarding Tender for Installation of German Hanger including (furniture arrangement, stage decoration, interiors, furnishings etc.), Audio Video, Electro-mechanical works, Catering Services and providing of other items for 'National Conference' at CRIYN, Jhajjar, Haryana to be held on **5th & 6th February, 2026**.

As per the NIT, Pre-Bid meeting conducted through online & physical mode at Council's Hqrs. on 22.01.2026 at 11:00 a.m. onwards wherein various points/general queries raised by the different bidders were discussed with Committee members. Since, proposed points/queries raised by the bidders are generally a part of Tender which basically mandatory in nature of any tender. However, the Tender Committee deliberated on these points and decided the following additions/corrections/amendments in the tender for smooth and appropriate in execution of work: -

(A) The following items/points have been included in the NIT: -

1. One VIP Lounge with all necessary amenities to be created
2. Mobile Toilets -10 (5 for Female + 5 for Male)
3. Dinning Area with Fire Radiant
4. Barricading for Main Hanger
5. LED Par Lights for Dinning Area (General Public)
6. Platform for VIP Sitting Area or Entire Hanger Area
7. EMD exemption will be allowed for MSME as per government rules
8. Bouquet arrangement for welcome of VIPs for two days
9. Waste Management Arrangement for two days
10. Name plates for VIPs and Speakers (list will be provided to successful bidder)
11. Platform Clothing for main Hanger
12. Point no. 5 & 6 of NIT may be considered one together
13. Design Template for Stage Banner, Main Gate Banner & main road entrance banner, Standees etc. (Logo, theme, matter, sample format with background pattern) is attached at **Annexure-A**.

15. A mandatory technical presentation meeting is to be convened and will be held on 28.01.2026 at 11:00 a.m. at CCRYN Hqrs., 61-65, Institutional Area, Opposite D Block, Janakpuri, New Delhi.

(B) Evaluation criteria:

Evaluation will be done in two parts

(i) Technical Bid = 70 %

(ii) Financial Bid = 30 %

Technical Bid

- i) All the requisite documents etc. mentioned in the Check list of Tender should be fulfilled as per NIT.
- ii) Evaluation will be made under Combined Quality cum Cost Based System (CQCCBS).
- iii) Under CQCCBS, the technical proposals (detailing the designs, plan of action and display and design photographs) will be allotted a weightage of 70 marks. The technical proposal will be opened on the specified date and only firms/agencies securing a minimum of 50 marks in technical evaluation shall be considered technically qualified. Financial proposals of only those firms who are technically qualified shall be opened publicly on the date & time specified to be notified, in the presence of the agencies' representative who choose to attend. The name of the firms/agencies, their technical score (if deemed necessary by the employer) and their financial proposal shall be read aloud. Financial proposals will be allotted weightage of 30 marks.

The Proposed Quality Evaluation Criteria will be TECHNICAL PROPOSAL
(Total weightage 70 marks)

- iv. The duly constituted Tender Evaluation Committee shall evaluate the Technical bid and the firm who are found eligible is entitled to participate in financial bid.
- v. Proposal with the lowest cost may be given a financial score of 100% and other proposals will be given financial score that are inversely proportional to their prices i.e. w.r.t. the lowest offer.
- vi. On the basis of the combined weighted score for quality and cost, the Agencies shall be ranked in terms of the total score obtained. The proposal obtaining the highest total combined score in evaluation of quality and cost will be ranked as H-1 followed by the proposals securing lesser marks as H-2, H-3 etc. In case H-1 bidder withdraws, second highest bidder H-2 will be considered.
- vii. The total score, both technical and financial, shall be obtained by weighing the quality and cost scores and adding them up.

* The total cost is increased by Rs. 5 Lakhs (i.e. Rs. 60 Lakhs) and EMD value will be revised accordingly (i.e. Rs. 1.20 Lakhs).

The final decision of Competent Authority, CCRYN shall be acceptable to all the bidder in this context.


