Applications are invited, in duplicate, through proper channel from eligible candidates for filling up the post of Director, National Institute of Naturopathy (NIN), Pune, an autonomous organization under the Ministry of Ayush, Government of India.

2. The National Institute of Naturopathy (NIN), Pune, established in 1986, with the objective to conduct, provide, facilitate and encourage research in all aspects concerning human health and in all fields of Naturopathy, to impart and provide facilities for encouraging training in all fields of Naturopathy and / or combination therapy, to provide and encourage facilities for all kinds of treatments in all fields of Naturopathy and / or Combination Therapy.

National Institute of Naturopathy (NIN) with the active support of Ministry of Ayush have set up its three units, namely NIN- Bapu Bhavan (OPD), Pune; Nisarg Gram (OPD and 250-bedded IPD) at Yewalewadi, Pune and Nisarg Arogya Sadhana Kendra (OPD/ 20-bedded IPD) at Gohe Budruk, District Pune.

(c) Bachelor of Naturopathy & Yogic Science (BNYS) degree from a UGC recognized university

OR

(d) A PG Degree in any subject from a UGC recognized university and a Diploma in Yoga/ Naturopathy of at least one year duration from a UGC recognized university.

OR

(e) A degree from recognized institute under IMCC Act 1970 with PG degree / diploma in Yoga from UGC recognized university.

OR

(f) MD degree in the subject (Yoga or Naturopathy) or PhD in Yoga/Naturopathy from a recognized University

**Experience:**

(a) 12 years' experience in research or teaching in Yoga and / or Naturopathy.

OR

(b) 12 years' experience in Administration in Central / State Government/ University including at least 4 years' experience in Pay Level-12/ PB-3, GP-7600 or equivalent.

(C) Holding analogous post in Central/ State Government/ University/ Autonomous bodies/ Educational Institutes/ Hospitals/ Private Organization, Institutes in Pay Level 13.
