- 2) All candidates shortlisted for interview will have to bring their original documents for verification. Only those candidates who clear the document verification process and eligibility criteria as laid down in the Recruitment Rules will be scheduled for Interview.
- 3) As per existing Recruitment Rules, 70% weightage shall be given to Examination and 30% to the Interview. However, the selection of the candidate as decided by the Competent Authority, Ministry of Ayush shall be final
- 4) Appointment to the post is subject to verification of documents and other eligibility criteria.
- 5) Errors and omissions in result notification and selection process are subject to corrections as per rules.
